Inside flea market spaces: \$60.00 each. (10ft x 5ft)/Outside flea market spaces: \$60.00 (15ft wide x 25ft deep)

Pricing is the same whether you stay for one day or all three days. You may buy as many spaces as needed. **Inside space is limited.**

****No Site or Space may be swapped, leased or sold without Flea Market Management's approval****

To reserve a space, payment in full must be in advance, postmarked by **July 10th 2026** after which date it will be assigned to another seller if your payment has not been received. If space is not reserved, it is possible you may not get a space due to limitations on space available. The flea market management will assign all spaces.

Set up time: 8:00 a.m. Thursday August 20th. **Absolutely no setups before 8:00a.m. on Thursday August 20th.**

****This means no parking or unloading in your spot until 8:00a.m. on the day of setup. ****

Buildings are opened at 8 a.m., locked 6 p.m. Security is provided overnight at the show grounds. The Badger Steam and Gas Engine Club and/or its members are not responsible for the loss or damage to any items you bring to this show.

RULES

1. When setting up inside a building, you may drive up to or into your designated building to load or unload, but then you must park your vehicle in the public parking lot area of the show grounds. **NO EXCEPTIONS!**
2. **NO** excess junk left behind: Sellers are responsible for cleaning up their spots before leaving the show. Please use garbage bags for your trash. All cardboard is to be broken down and tied or taped without exception. Any tires left behind will incur a \$25.00 charge per tire. *If this is not adhered to, Flea Market lot prices will increase due to increased cleanup and landfill cost. *
3. **NO** Generators May Be Used Between **10:30 PM AND 6:00 AM.**
4. **NO** Concealed Weapons on Grounds
5. **NO** Food or Drink Sales
6. **NO** Firearm, Ammunition, Knife or Sword Sales Allowed. ***Pocket Knives can be sold if the blade measures 3in or less***
7. Vendor entry Friday, Saturday & Sunday 6:30AM-8AM
8. **NO** gate entry after 8am. The Gate will close at 8am and remain closed until 3pm. **NO ONE WILL BE ALLOWED IN TO PICK UP UNTIL AFTER 3:00 PM.** Transport for tips available to your buyers coordinated at main gate.

SECOND TIME VIOLATION: YOU WILL BE ASKED TO PACK UP AND LEAVE WITH NO REFUND OF MONEY!!
